We are essentially in remote and dangerous areas, in nature, and dealing with its inconsistencies and uncertainties, slippery rocks, ledges, uneven ground, water flows and on it goes... So if unsure on any part of our T and C's, we advise you to seek legal advice prior to booking into our adventure. Regional circumstances and regulations, contractual obligations to suppliers, and matters relating to location, product type and supply logistics may cause these to be varied slightly for specific products, or specific destinations.

Land based travel arrangements and prices detailed are provided and coordinated, by **Hurleys Fly Fishing Adventures(HFFA)**

- Sales of services as contained in our publications are made by HFFA as an agent only for the person, business or company providing the services.
- HFFA does not accept responsibility for any change in prices or variation of services as shown, particularly all services and prices out of our control are subject to change without notice.
- HFFA does not accept any liability for the acts, omissions or default, whether negligent or otherwise, of those service providers in connections pursuant to a contract between them and yourselves and over whom we have no direct control. TERMS AND CONDITIONS OF BOOKING

Rates and Price Variations: We reserve the right to vary prices and rates in the event of changes. We are not liable in any way if any increase occurs, particularly if out of our control. Rates quoted are appropriate to the particular product at the time of quoting and these rates may change prior to the travel date, although unlikely.

Deposits: Bookings are required to pay a non refundable holding deposit of \$500 for NZ trips, per person at the time of confirmation. Bookings are not guaranteed accepted, and the trip position not locked in, until the deposit is made and received. Bookings travelling within 30 days will be required to pay the deposit and final payment at the time of confirmation. **Final Payment:** Full or final payment is due at least 30 days prior to the travel date for NZ, and if completed within due time includes full season license worth \$180.

Standard Cancellation Policy:

- Deposited bookings cancelled prior to travel - Deposit is non refundable.
- Fully paid bookings cancelled 60 days or more prior to travel - Deposit PLUS any fees levied by the supplier are non refundable. We endeavour where possible to resell your position to minimise your costs and pass on any savings.
- Bookings cancelled inside 30 days – Full payment completely non refundable.

Change of Itinerary after Adventure Has Commenced:

Any alteration or cancellation of services within 7 days or after your holiday has commenced will incur penalties. There is no refund for unused services.

Refunds: No refunds will be made for services once travel arrangements have commenced. No guarantee is provided or warranted that any refund will be available. Claims must be made within 7 days of completion of travel arrangements. Refunds will not be made for bookings cancelled due to inclement weather or illness; these must be claimed through your travel Insurance.

Reporting of Incidents: Any abnormal incidents including injuries, service problems, cancellation of a service or dissatisfaction must be reported to HFFA, or the HFFA host during the event to allow us an opportunity to rectify the situation or provide assistance.

GENERAL

Currency and validity of Rates: Prices are quoted in Australian dollars, unless otherwise indicated, and rates are generally valid for the dates indicated.

Travel Insurance: It is mandatory that you take out Travel Insurance. It is ESSENTIAL that this insurance covers you for lost luggage, involuntary cancellation of your holiday including airfare(s), and any urgent medical situations that may arise. We are outdoors, and the unexpected can happen, and HFFA does not, nor do any of its agents accept any responsibility for costs associated from any extraordinary events, regardless of fault, that may occur for the duration of your adventure. Please ensure you provide a copy of insurance prior to travel so that we are clear of your cover and can contact them directly in the unlikely event if you are unable to.

Accommodation: Accommodation is as specified. We reserve the right to offer alternative accommodation of a similar standard in the case the accommodation operator overbooks their property or for any reason beyond our control. All rates are subject to change without notice, particularly if out of our control, although unlikely.

Quotations: All quotations are subject to availability of services quoted and are not guaranteed until the booking is confirmed and deposit received.
